On September 7, 2022, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to complete two (2) hours of education on the topic of "responsible prescribing of controlled substances for the treatment of acute dental pain" within ninety (90) days and to pay \$614.00 in costs of the proceeding within 90 days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice dentistry (license no. 4925-15) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
