On September 7, 2022, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") limiting Respondent's license to practice dentistry. Respondent was required to complete twelve (12) hours of education on the topic of "endodontic treatment" pursuant to the term of the Order within 120 days and to pay \$3509.17 in costs of the proceeding within 120 days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice dentistry (license no. 2631-15) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
