On September 8, 2022, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") limiting Respondent's license to practice as a licensed practical nurse and registered nurse. Respondent was required to complete three (3) hours of education on the topic of "patient assessment" and three (3) hours of education on the topic of "nonverbal cues of pain in the elderly" within ninety (90) days pursuant to the terms of the Order and to pay \$525.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

### ORDER

Respondent's license to practice as a licensed practical nurse and registered nurse 1. (license numbers 319981-31 and 1087451-30 respectively) are returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credential are removed.

3. This order is effective the date of its signing.
