On October 12, 2022, the Wisconsin Board of Nursing (“Board”) issued an Order Granting Limited License (“Order”) limiting Applicant’s registered nursing license for a minimum five (5) year period. Applicant’s license is currently limited with certain terms and conditions.

On November 10, 2022, the Board considered Applicant’s request for acceptance of Monroe County OWI Treatment Court for Drug/Alcohol Monitoring. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant’s request for acceptance of Monroe County OWI Treatment Court for Drug/Alcohol Monitoring is hereby GRANTED. The Treatment Court shall be considered as meeting the requirement for random on-demand drug/alcohol testing (Section A.19-A.25) from the Order.
2. Applicant shall sign up for and participate in the standard Approved Program drug monitoring at such time as the Monroe County program ends.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
