The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Lisa M. Engelbrecht, R.N., (Year of Birth 1966) is licensed in the state of Wisconsin as a registered nurse, having license number 130971-30, first issued on October 27, 1998 and current through February 28, 2022. This license is suspended as of August 13, 2021. Pursuant to Wis. Stat. § 440.08(3), Respondent may apply to renew her license through February 28, 2027. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Elkhorn, WI 53121.

Prior Discipline

2. On April 9, 2020, the Board issued Order Number 0006744 (Limitation Order) reprimanding Respondent, requiring her to complete continuing education, and requiring

Respondent to enroll and participate in a drug and alcohol monitoring program for at least two years. Respondent was also required to provide a copy of the Order to her employer. The Board found that Respondent, while working as a registered nurse at a hospital in Pewaukee, Wisconsin, obtained and ingested Xanax without a prescription, and committed a medication error by withdrawing two tablets of Lyrica and only administering one.

3. On August 13, 2021, the Board suspended Respondent's license after she failed to pay costs, complete the required education, and participate in a drug and alcohol monitoring program as required by the Limitation Order.

Current Case

- 4. On approximately 14 dates between August 13 and September 4, 2021, while Respondent's license was suspended, Respondent worked as a registered nurse at a dialysis center in Waukesha and Fox Brook, Wisconsin (Facility).
- 5. Respondent did not provide her employer with a copy of the Limitation Order or otherwise notify her employer that her license was limited or subsequently suspended.
- 6. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. By the conduct described in the Findings of Fact, Respondent practiced nursing without an active license within the meaning of Wis. Admin. Code § N 7.02(1)(d).
- 3. By the conduct described in the Findings of Fact, Respondent violated any term, provision, or condition of any order of the Board within the meaning of Wis. Admin. Code § N 7.03(1)(g).
- 4. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b) and (d), and Wis. Admin. Code § N 7.03.

ORDER

- 1. The attached Stipulation is accepted.
- 2. Respondent is REPRIMANDED.
- 4. Within 90 days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$675.00.
- 5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:

- 6. In the event Respondent violates any term of this Order, Respondent's license (number 130971-30), or Respondent's right to renew her license, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
 - 7. This Order is effective on the date of its signing.

Respondent Lisa M. Engelbrecht, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
 - Respondent is informed that should the Board adopt this Stipulation, the Board's Decision and Order is a public record and will be published in accordance with standard content procedure.
 - Respondent is further informed that should the Board adopt this Stipulation, the Sipulation and Order will be reported as required by the National Practitioner Cank (NPDB) Guidebook and as otherwise required by any licensure compact or any other actideral law.
 - The Division of Legal Services and Compliance joins Respondent in anding the Board adopt this Stipulation and issue the attached Final Decision and Order.
