The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

### **FINDINGS OF FACT**

1. Respondent Carrie A. Walters, S.A.C., S.A.C.-I.T., (Year of Birth 1980) is certified in the state of Wisconsin as a substance abuse counselor, having certification number 16579-131, first issued on August 29, 2022, and current through February 28, 2023. Respondent is also certified in the state of Wisconsin as a substance abuse counselor-in-training, having certification number 18918-130, first issued on July 5, 2019, and current through February 28, 2023.

2. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in Fond du Lac, Wisconsin 54935.

3. At all times relevant to this proceeding, Respondent was employed as a substance abuse counselor-in-training at a community-based residential treatment facility located in Fond du Lac, Wisconsin (Facility).

4. On August 31, 2022, Respondent sent a letter to the Facility admitting to engaging in "inappropriate messages and behavior" with a client while the client was in residential treatment and under her care during March and April 2022.

5. On September 11, 2022, Respondent represented to the Department that the relationship began when she helped the client find an apartment and began messaging him via her personal Facebook account. After that, their messages became increasingly inappropriate, involving "love and sex." Respondent maintains there was no "sexual involvement" but admits to kissing the client in her office and having "physical contact" in her vehicle.

6. The relationship ended at the end of April 2022 when the client left residential treatment and Respondent moved to California.

7. Respondent has fully cooperated with the Department's investigation, expressed remorse regarding her actions, and is undergoing therapy.

8. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Department has jurisdiction to act in this matter pursuant to Wis. Stat. § 440.88 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code § SPS 164.01(2)(m) by engaging in inappropriate sexual contact, exposure, gratification, or other sexual behavior with or in the presence of a patient.

3. By the conduct described in the Findings of Fact, Respondent violated Wis. Admin. Code § SPS 164.01(2)(n) by failing to avoid dual relationships or relationships that may impair the substance abuse professional's objectivity or create a conflict of interest.

4. As a result of the above violations, Respondent is subject to discipline pursuant to Wis. Stat. § 440.88(6) and Wis. Admin. Code Ch. SPS 164.

#### ORDER

1. The attached Stipulation is accepted.

2. The voluntary SURRENDER by Respondent of her certifications to practice as a substance abuse counselor (number 16579-131) and a substance abuse counselor-in-training (number 18918-130) in the state of Wisconsin, as well as her right to renew such certifications, is accepted.

In the event Respondent petitions the Department for reinstatement of her 3. certification to practice as a substance abuse counselor or substance abuse counselor-in-training in the state of Wisconsin, or applies for another credential in the state of Wisconsin under Wis. Stats. chs. 440 through 480, Respondent shall pay the costs of this matter in the amount of \$420.00 before any petition or application for a credential will be considered by the applicable board or Department.

Respondent shall not petition the Department for reinstatement for at least one (1) 4. year from the date of this Order. If the Respondent petitions for reinstatement after one year, whether to grant a certification and whether to impose any limitations or restrictions on any certification granted shall be in the sole discretion of the Department and such decision is not reviewable.

## Division of Legal Services and Compliance Case No. 22 RSA 035

Respondent Carrie A. Walters, S.A.C., S.A.C.-I.T., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Department of Safety and Professional Services (Department). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Department, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the

Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Department, the parties agree not to contend that the Department has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance may appear before the Department, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with deliberations on the Stipulation.

7. Respondent is informed that should the Department adopt this Stipulation, the Department's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. Respondent is further informed that should the Department adopt this Stipulation, the Department's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.

9. The Division of Legal Services and Compliance joins Respondent in recommending that the Department adopt this Stipulation and issue the attached Final Decision and Order.
