FINAL DECISION AND ORDER

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Kathleen A. Jopke, R.N. (Respondent), (Year of Birth 1967) is licensed in the state of Wisconsin as a registered nurse, with multistate privileges pursuant to the Nurse License Compact (Compact), having license number 109307-30, first issued on March 20, 1992, and current through February 29, 2022<sup>1</sup>. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is in New Berlin, Wisconsin 53151.

<sup>1</sup> Respondent started the process to renew her license on January 14, 2022, and that renewal is pending review. Respondent's license remains active via Wis. Stat. § 227.51(2).

2. At all times relevant to this proceeding, Respondent worked as a registered nurse at a hospital located in Milwaukee, Wisconsin (Hospital).

3. On October 18, 2021, in Brookfield Municipal Court Case Number AT4051051, Respondent was convicted of operating while under the influence – OWI 1<sup>st</sup>, in violation of Wis. Stat. § 346.63(1). Respondent was assessed a fine and required to complete an Alcohol and Other Drug Abuse (AODA) assessment. The AODA assessment related to this event found “Irresponsible Use of Alcohol.”

#### 22 NUR 304

4. During the 1<sup>st</sup> quarter of 2022, Nurse A commented to Respondent that Nurse B was hyper and needed medication. Nurse A further commented to Respondent that she could put attention deficit and hyperactivity disorder (ADHD) medication into Nurse B’s coffee to see if it helps Nurse B. The next day, Nurse A placed prescription drug (ADHD) medication in Nurse B’s coffee without her knowledge. Nurse A told Respondent what she had done. When Nurse B returned and began drinking her coffee, she discovered the ADHD medication in the coffee and discarded the rest of the coffee. Nurse A admitted her actions and all three laughed. The aforementioned occurred while all three nurses were on break at work, at a healthcare institution.

5. Respondent admits that Nurse A told her that Nurse A placed medication in Nurse B’s coffee cup when Nurse B was out of the room. Respondent did not tell Nurse B about the medication in her coffee cup when Nurse B returned to the room and prior to Nurse B drinking her coffee containing the medication.

6. Respondent did not inform a supervisor at the healthcare institution, or the Board of Nursing, about the events referenced in paragraphs 4 and 5.

7. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Respondent failed to report to the Board or institutional supervisory personnel any violation of the rules of this chapter by a licensee within the meaning of Wis. Admin. Code § 7.03(1)(i).

3. As a result of the above conduct, Respondent is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b), and (d), and Wis. Admin. Code § N 7.03.

#### ORDER

1. The attached Stipulation is accepted.

2. Respondent is REPRIMANDED.

3. Respondent's license to practice as a registered nurse (license number 109307-30), and privilege to practice in Wisconsin pursuant to the Compact, are LIMITED as follows:

- a. Within ninety (90) days of the date of this Order, Respondent shall at her own expense, successfully complete six (6) hours of education on the topic of ethics offered by a provider pre-approved by the Board's monitoring liaison, including taking and passing any exam offered for the course(s), as well as complete the Wisconsin Nurse Practice Act course offered by the NCSBN.
- b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
- c. The Board's monitoring liaison may change the number of credit hours and/or education topics in response to a request from Respondent. The monitoring liaison may consider the topic availability and/or hours of education when determining if a change to the ordered education should occur.
- d. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all the ordered education.

4. Within ninety (90) days from the date of this Order, Respondent shall pay COSTS of this matter in the amount of \$935.00.

5. Any requests, petitions, payments of costs (made payable to Department of Safety and Professional Services), and other information required by this Order shall be submitted to:


6. Pursuant to Wis. Stat. § 441.51(5)(b), Respondent's multistate licensure privilege to practice in all Compact states besides Wisconsin is deactivated during the pendency of this Order.

7. In the event Respondent violates any term of this Order, Respondent's license (number 109307-30), or Respondent's right to renew her license, may, in the discretion of the

Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

8. This Order is effective on the date of its signing.

STIPULATION

Division of Legal Services and Compliance Case Nos. 21 NUR 659 and 22 NUR 304

Kathleen A. Jopke, R.N. (Respondent), and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Lauren Wick.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not


accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.


7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. Respondent is further informed that should the Board adopt this Stipulation, the Board's Final Decision and Order will be reported as required by the National Practitioner Databank (NPDB) Guidebook and as otherwise required by any licensure compact or any other state or federal law.


9. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
