On April 3, 2008, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license (#133915-30) for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.
