On February 13, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On October 12, 2023, the Board considered Respondent's requests for termination of treatment, termination of AA/NA reports, removal of reporting requirement for medications & allowing consumption of certain OTC drugs and certain foods, reduction in drug testing frequency, and access to controlled substances. Based upon the information of record, the Board finds and makes the following:

#### ORDER

- 1. Respondent's request for termination of treatment is hereby GRANTED.
- 2. Respondent's request for access to controlled substances is hereby GRANTED.
- 3. Respondent's request for termination of AA/NA reports is hereby DENIED.
- 4. Respondent's request for removal of the reporting requirement for medications and to allow consumption of certain OTC drugs & certain foods is hereby DENIED.
- 5. Respondent's request for reduction in drug testing frequency is hereby DENIED.
- 6. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
- 7. This order is effective the date of its signing.
