On April 10, 2014, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order (Order) suspending Respondent's practical nursing license (#305910-31) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On December 14, 2023, the Board considered Respondent's requests for a reduction in drug and alcohol screens, termination of direct supervision and to remove the work setting restrictions for home health and hospice care. Based upon the information of record, the Board finds and makes the following:

### <u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens is GRANTED. Respondent is now required to test at a frequency of no less than thirty-six (36) tests per year.

2. Respondent's requests to terminate direct supervision and the work setting restrictions for home health and hospice care are hereby DENIED.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
