On March 12, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On August 10, 2023, the Board considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Board finds and makes the following:

#### **ORDER**

- 1. Respondent's request for full licensure of her professional nursing license (#158779-30) is hereby GRANTED, once all the requirements of renewal are met.
- 2. All limitations and encumbrances upon Respondent's credential are hereby removed.
