On April 19, 2018, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent Fuller's real estate broker license with certain terms and conditions.

On August 17, 2023, the Board considered Respondent Fuller's request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent Fuller's request for the return of her real estate broker license (no. 34122-90) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
