On March 14, 2019, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On February 9, 2023, the Board considered Respondent’s request to terminate direct supervision. Based upon the information of record, the Board finds and makes the following:
