On September 18, 2019, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") limiting Applicant's registered nurse license with certain terms and conditions, including participation in a drug monitoring program.

The Board designee has considered Applicant's request for a reduction in the frequency of drug screens. Based upon the information of record, the following is entered:

## <u>ORDER</u>

1. Applicant's request for a reduction in drug screens is hereby GRANTED. Applicant's frequency is reduced to not less than thirty-six (36) per year.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
