On October 10, 2019, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's registered nursing license with certain terms and conditions, including participation in a drug monitoring program.

The Board designee has considered Respondent's request for a reduction in the frequency of drug screens. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Respondent's request for a reduction in drug screens is hereby GRANTED. Respondent's frequency is reduced to not less than twenty-eight (28) urine screens per year and one (1) annual hair test.
- 2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 3. This order is effective the date of its signing.
