On August 5, 2020, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's practical nurse license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for violation of any provision.

Information has been received that demonstrates Respondent has failed to continually participate in the approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:

#### ORDER

- 1. The stay of suspension is removed, and Respondent's practical nurse license (#314949-31) is hereby SUSPENDED until further notice.
- 2. Respondent may petition the Board or its designee for reinstatement of the stay upon demonstrating continuous compliance with the terms and conditions of the Order for at least thirty (30) consecutive days.
  - 3. This order is effective immediately.
