On September 10, 2020, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order accepting the surrender of Respondent's license to practice advanced practice nurse prescribing (#6049-33). Prior to reapplying for licensure, Respondent shall not petition the Board of Nursing for reinstatement of her advanced practice nurse prescriber license for at least three (3) years from the date of the original order.

On October 23, 2023, the Board Designee considered Respondent's request for reinstatement of her credential. Based on the information of record, the Board finds and makes the following:
