On October 8, 2020, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order (Order) suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On December 14, 2023, the Board considered Respondent's request for early termination of this Order, and for the return of her full licensure. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her registered nurse license (license number 223541-30) to full, unrestricted status is hereby DENIED.
