On October 8, 2020, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education on “ethics and professionalism in nursing” and three (3) hours of education on “patient’s rights” within forty-five (45) days. The information of record demonstrates that Respondent has failed to comply with the education requirements and as a result the following is entered:

ORDER

1. Respondent’s professional nursing license (#138883-30) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
