On April 7, 2021, the Professional Engineer Section of the Wisconsin Examining Board of Architects, Professional Engineers, Designers, Professional Land Surveyors and Registered Interior Designers ("Section") issued a Final Decision and Order ("Order") limiting Applicant's professional engineer license with certain terms and conditions.

On July 27, 2023, the Section considered Respondent's request for removal of the limitations and the return of his license to full, unrestricted status. Based upon the information of record, the Section finds and makes the following:

ORDER

1. Applicant's request for the return of his professional engineer (#44859-6) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
