On April 21, 2021, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice medicine and surgery (#65403-21) with certain terms and conditions.

On November 15, 2023, the Board Designee considered Respondent's request for removal of the limitations and the return of his license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:
