On June 16, 2021, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions.

On December 14, 2023, the Board considered Applicant's requests to terminate work setting restrictions (C.3.), reduce the frequency of drug and alcohol screens to thirty-six (36) times per year, and reduce AA/NA meetings to one (1) per week. Based upon the information of record, the following is entered:

## <u>ORDER</u>

- 1. Applicant's requests for a reduction in the frequency of drug and alcohol screens to thirty-six (36) times per year and AA/NA meetings to one (1) per week are hereby GRANTED.
- 2. Applicant's request for termination of work setting restrictions (C.3.) is hereby DENIED.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
  - 4. This order is effective the date of its signing.
