On July 21, 2021, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice as a respiratory care practitioner (#3257-28) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 6, 2023, the Board Designee considered Respondent's request for a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

#### **ORDER**

- Respondent's request for a reduction in drug and alcohol screens is hereby 1. GRANTED. Respondent's frequency is reduced to not less than twenty-eight (28) times per year.
- All other terms and conditions of the Order not otherwise modified remain in full 2. force and effect.
  - 3. This order is effective the date of its signing.
