On July 28, 2021, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's real estate broker's license. Respondent was required to complete an education course on the topic of business ethics pursuant to the terms of the Order.

On April 28, 2022, Respondent's license was reinstated to full, unrestricted status based upon completing the education and paying costs of the proceedings, including the accrued interest. The check tendered by Respondent was returned by the bank for insufficient funds.

On June 23, 2022, an Order Rescinding Full Licensure was issued by the Real Estate Examining Board Liaison because Respondent had not satisfied the terms of the reinstatement.

Respondent has submitted proof that she successfully completed the required education and paid all overdue costs, including the accrued interest. As a result, the following is entered:

ORDER

- 1. Respondent's real estate broker's license (no. 58708-90) is returned to full, unrestricted status.
- 2. All limitations and encumbrances upon Respondent's credential are removed.
- 3. This order is effective the date of its signing.
