On August 12, 2021, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice as a registered nurse for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On October 12, 2023, the Board considered Respondent's request for a reduction in the frequency of drug and alcohol screens, termination of AA/NA meetings, termination of drug and alcohol treatment, and a change from direct supervision to general supervision requirement. Based upon the information of record, the Board finds and makes the following:

### <u>ORDER</u>

1. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to not less than twenty-eight (28) urine screens per year and one (1) annual hair test.

2. Respondent's request for reduction of AA/NA meetings is hereby GRANTED. Respondent shall attend AA/NA meetings at a frequency of not less than twice per month.

3. Respondent's request for termination of the drug and alcohol treatment requirement is hereby GRANTED.

4. Respondent's request for a change from direct supervision to general supervision requirement is hereby GRANTED.

5. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

6. This order is effective the date of its signing.
