On August 12, 2021, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order (Order) suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On December 14, 2023, the Board considered Respondent's request for termination of C.8., termination or reduction in drug, reduction of AA/NA meeting to monthly, and the termination of the treatment requirement. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the reduction of AA/NA meetings, the termination of the treatment requirement, and a reduction in drug and alcohol screens is hereby GRANTED. Respondent's drug testing frequency is reduced to not less than twenty-eight (28) screens per year and one (1) annual hair test. Respondent's AA/NA meeting frequency is reduced to not less than once per week.
2. Respondent's request for termination of C.8. is hereby DENIED.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
