On August 31, 2021, the Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's massage therapist or bodywork therapist license (#12272-146) with certain terms and conditions.

On November 9, 2023, the Board designee considered Respondent's request for removal of the limitations and the return of her license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her massage therapist or bodywork therapist license (#12272-146) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
