On September 2, 2021, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's pharmacist license for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On October 26, 2023, the Board considered Respondent's request for a reduction in the frequency of drug and alcohol screens, and modification to Provision C.26 of the Order. Based upon the information of record, the Board finds and makes the following:

ORDER

- 1. Respondent is hereby GRANTED a temporary reduction in drug and alcohol screens. Respondent's frequency is reduced to not less than fourteen (14) urine screens per year and one (1) annual hair test until he obtains employment as a pharmacist, at which time the frequency will be increased to not less than forty-nine (49) urine screens per year.
- 2. Respondent's modification request to Provision C.26. is hereby GRANTED. Provision C.26 of the Order is hereby modified as follows: Respondent shall obtain from his supervising pharmacist agreement to conduct a full and exact count of all controlled substances at the time of initial hire. The audit shall be conducted by and certified by a licensed pharmacist other than Respondent, who shall be approved by the Board. Respondent shall arrange for his employer to submit a letter to the Department Monitor following quarterly inspection reports required under Wisconsin Admin. Code § Phar 8.05(2). Letters submitted based on quarterly inspection reports shall detail whether any discrepancies, missing drugs or any other deviations were uncovered during the inspections.
- 3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
 - 4. This order is effective the date of its signing.
