On September 9, 2021, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license and Advanced Practice Nurse Prescriber license with certain terms and conditions.

On January 12, 2023, the Board considered Respondent’s request for removal of the limitations and the return of her licenses to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent’s request for the return of her professional nursing license (#136361-30) and Advanced Practice Nurse Prescriber license (#4359-33) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent’s credential are hereby removed.
3. This order is effective the date of its signing.
