On December 15, 2021, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for a period of twelve (12) months, the Respondent served the first six (6) months of his suspension, the remaining six months were stayed per the terms of his Order. Respondent's license was limited requiring him to complete the *Medical Ethics, Boundaries, and Professionalism* course offered by Case Western Reserve University School of Medicine for a total of 15.75 AMA PRA Category 1 Credits within six (6) months and to pay \$1,188.00 in costs of the proceeding within 90 days.

Based upon the information of record, which includes proof that Respondent has completed the education and submitted the payment for costs in full, the following is entered:

## **ORDER**

- 1. Respondent's license to practice medicine and surgery (license no. 53594-21) is returned to full, unrestricted status.
  - 2. All limitations and encumbrances upon Respondent's credential are removed.
  - 3. This order is effective the date of its signing.
