On January 3, 2022, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order") granting Applicant a limited licensed practical nurse credential (no. 325465-31) with certain terms and conditions, including participation in a drug monitoring program.

The Board designee has considered Applicant's request for a reduction in the frequency of drug screens. Based upon the information of record, the following is entered:

## <u>ORDER</u>

1. Applicant's request for a reduction in drug screens is hereby GRANTED. Applicant's frequency is reduced to not less than thirty-six (36) per year and one (1) annual hair test.

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
