On April 14, 2022, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's registered nurse license for an indefinite period. Respondent may petition for a stay of suspension upon providing proof, which is determined by the Board or its designee to be sufficient, that Respondent has been in compliance with the provisions of Section C and D of this Order for a period of at least thirty (30) consecutive days.

Respondent's petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Respondent's registered nurse license (license number 138836-30) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
3. This order is effective the date of its signing.
