On April 14, 2022, the Wisconsin Board of Nursing (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s professional nursing license (license no. 138836-30) for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

Information submitted in support of Respondent’s request for a reduction in the frequency of drug and alcohol screens has been reviewed. Based upon the information of record, which demonstrates that Respondent is eligible for a temporary reduction at this time, the following is entered:

ORDER

1. Respondent is hereby GRANTED a temporary reduction in drug and alcohol screens. Respondent’s frequency is reduced to not less than fourteen (14) urine screens per year and one (1) annual hair test until she obtains employment as a nurse, at which time the frequency will be increased to not less than forty-nine (49) screens per year (one of which may be a hair test at the Board’s discretion).

2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
