On August 24, 2023, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") Designee considered Respondent's request to surrender her professional counselor license, which is currently limited pursuant to the Final Decision and Order issued on May 19, 2022. Based upon the information of record, the Board Designee finds and makes the following:

ORDER

1. The surrender of Respondent's professional counselor license (#5955-125) is hereby accepted.
2. Respondent shall not petition the Section for reinstatement of her professional counselor license for at least one (1) year from the date of this Order. If the Respondent petitions for reinstatement after one year, whether to grant a credential and whether to impose any limitations or restrictions on any credential granted shall be in the sole discretion of the Section and such decision is not reviewable.
3. This order is effective the date of its signing.
