On June 9, 2022, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's registered nurse license for an indefinite period. Respondent may petition for a stay of suspension upon Respondent providing proof that she has been in compliance with Sections C and D of the Order for a period of at least ninety (90) consecutive days.

Respondent's petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

### <u>ORDER</u>

1. The suspension of Respondent's registered nurse license (license number 143931-30) is hereby STAYED.

2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
