On August 1, 2022, the Wisconsin Board of Nursing (“Board”) issued an Order Granting Limited License (“Order”), granting Applicant a limited a professional nursing license with certain terms and conditions, including participation in a drug monitoring program.

The Board designee has considered Applicant’s request for a reduction or elimination in the frequency of drug screens and AA/NA meetings. Based upon the information of record, the following is entered:

ORDER

1. Applicant’s request for a reduction in drug screens is hereby GRANTED. Applicant’s frequency is reduced to not less than thirty-six (36) urine screens per year and one (1) annual hair test.
2. Applicant’s request for a reduction of AA/NA attendance frequency is hereby GRANTED. Respondent shall attend AA/NA meetings at a frequency of not less than once per week.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
