On September 21, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order (“Order”) requiring Respondent to complete the continuing education course “Intensive Course in Controlled Substance Prescribing” offered by Case Western Reserve University School of Medicine within one hundred-eighty (180) days and pay \$2,498.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent’s medicine and surgery license (#40135-20) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent’s credential are removed.
3. This order is effective the date of its signing.
