On October 13, 2022, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent is in violation of the terms of the Order. As a result, the following is entered:

### <u>ORDER</u>

1. Respondent's professional nursing license (#128557-30) is hereby SUSPENDED until further notice.

2. Respondent may petition for termination of suspension upon demonstrating continuous, successful compliance with the terms and conditions of the Order for at least the most recent sixty (60) days.

3. This order is effective the date of its signing.
