On October 24, 2022, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's certified residential appraiser certificate of licensure. Respondent was required to complete the National USPAP course (15 hours), Residential Market Analysis and Highest & Best Use (15 hours), Land and Site Valuation (7 hours), and Appraiser Self Protection: Documentation and Record Keeping (4 hours) pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

1. Respondent's certified residential appraiser certificate of licensure (no. 1952-4) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
