On November 9, 2022, the Wisconsin Radiography Examining Board issued a Final Decision and Order ("Order") limiting Respondent's radiography license with certain terms and conditions. On April 10, 2023, Respondent's license was suspended for violation of the Order.

Based upon the information of record, which includes proof that Respondent is now in compliance with the terms and conditions of the Order, the following is entered:

ORDER

1. The suspension of Respondent's radiography license (#8369-142) is hereby terminated with the following stipulations:
  - a.) Any further missed testing will result in automatic suspension of the license
  - b.) If the suspension is reinstated at any point during the original monitoring requirement time period, per RAD 6.01(4) the original order will be closed and a new order will be created with harsher penalties.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
