On December 8, 2022, the Wisconsin Board of Nursing (Board) issued an Order Granting Limited License (Order) limiting Applicant's professional nursing license with certain terms and conditions.

On December 14, 2023, the Board considered Applicant's requests for full licensure, a reduction in drug screens to 36 screens per year, a reduction in AA/NA meetings to once per week and frequency of treatment sessions to be set by treater. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Applicant's request for full licensure is hereby DENIED.
2. Applicant's request for a reduction in drug and alcohol screens is hereby GRANTED. Applicant's frequency is reduced to not less than 36 urine screens per year.
3. Applicant's request for reduction in AA/NA meetings to once per week is hereby GRANTED.
4. Applicant's request for the frequency of treatment sessions to be determined by the treater is hereby GRANTED.
5. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
6. This order is effective the date of its signing.
