On December 21, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete twenty (20) hours of education on "responsible opioid prescribing" and eight (8) hours of education on "evaluation and treatment documentation" within ninety (90) days and pay \$3,334.00 in costs of the proceeding within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's license to practice medicine and surgery (#64548-20) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
