On December 21, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete eight (8) hours of education on "hysteroscopies, including intra-operative and post-operative emergencies and complications," And pay \$1,524.00 in costs of the proceeding within ninety (90) days. Respondent was also required to read and review the following articles:

4. "Complications of Hysteroscopy: A Prospective, Multicenter Study", Jansen, Frank Willem et. al., OBGYN 96(2)266-270, August 2000.
