On December 21, 2022, the Wisconsin Medical Examining Board issued a Final Decision and Order (“Order”) requiring Respondent to complete three (3) hours of education on “professional ethics” within ninety (90) days and pay \$1,062.00 in costs of the proceeding within ninety (90) days.
