On January 4, 2023, the Wisconsin Dentistry Examining Board issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education in "treatment planning" and four (4) hours of education in "best practices for fixed prosthodontics" within 90 days.
