On January 13, 2023, the Wisconsin Department of Safety and Professional Services issued a Final Decision and Order ("Order") requiring Respondent to complete six (6) hours of education on "recordkeeping for midwives," six (6) hours on the topic of "gestational hypertension," and three (3) hours of education on "effective communications with clients and providers" within one hundred-twenty (120) days. Respondent was also ordered to pay costs in the amount of \$1,249.00 within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

1. Respondent's Midwife license (#47-49) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
