On January 24, 2023, the Cosmetology Examining Board (Board) issued its Final Decision and Order in the above-captioned matter by which the Board ordered that pursuant to Wis. Stat. § 440.22, the costs of this proceeding be assessed against Respondent. The Board received the Affidavits of Costs from the Division of Legal Services and Compliance and Division of Hearings and Appeals. The Board considered the Affidavits of Costs on August 28, 2023, and orders as follows:

## <u>ORDER</u>

Pursuant to Wis. Stat. § 440.22, the costs of this proceeding in the amount of \$2,275.72 are assessed against Respondent and shall be payable by Respondent to the Department of Safety and Professional Services (Department). Failure of Respondent to make payment on or before August 28, 2024, shall constitute a violation of the Order unless Respondent petitions for and the Board grants a different deadline. Should Respondent violate any term of this Order, including failure to pay as directed via an approved petition for a different deadline, Respondent's credential may be immediately suspended and remain suspended until Respondent comes into compliance with the terms of this Order. Under Wis. Stat. § 440.22(3), the Department may not restore, renew or otherwise issue any credential to Respondent until Respondent has made payment to the Department in the full amount assessed.
