On February 9, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order ("Order") requiring Respondent to complete three (3) hours of education in "medication documentation" and three (3) hours of education in "appropriate prescribing for the APNP" within ninety (90) days. Respondent was also required to pay \$1,050.00 in costs within ninety (90) days.

Based upon the information of record, which includes proof that Respondent has now completed the education, the following is entered:

1. Respondent's professional nursing license (#117896-30) and advance practice nurse prescriber license (#1323-33) are hereby returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credentials are removed.
