On April 13, 2023, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license (#146197-30) with certain terms and conditions. Pursuant to the Order, Respondent’s license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to participate in the approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:

1. Respondent’s professional nursing license (#146197-30) is hereby SUSPENDED until further notice.
