On April 7, 2023, the Wisconsin Nursing Home Administrators Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$1,377.00 in costs of the proceeding and complete two (2) hours of education in "Resident Rights", two (2) hours of education on "Resident Care", two (2) hours of education on "Resident Sexuality", and four (4) hours of education on "Resident Abuse/Neglect", all within ninety (90) days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements. Therefore, the following is entered:

ORDER

1. Respondent's license to practice as a nursing home administrator in the state of Wisconsin (#2993-65) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
